ANNEX 1

Below is an extract of information provided by IFRA in relation to types of application present in each IFRA Category. Additional information about IFRA Categories can be found in the Guidance to IFRA Standards, issued by IFRA.

IFRA Category	Product Type
IFRA Category 1	Products applied to the lips
IFRA Category 2	Products applied to the axillae
IFRA Category 3	Products applied to the face/body using finger tips
IFRA Category 4	Products related to fine fragrances
IFRA Category 5A	Body lotion products applied to the face and body using the hands (palms), primarily leave-on
IFRA Category 5B	Face moisturizer products applied to the face using the hands (palms), primarily leave on
IFRA Category 5C	Hand cream products applied to the hands using the hands (palms), primarily leave on
IFRA Category 5D	Baby creams, baby oils and baby talc
IFRA Category 6	Products with oral and lip exposure
IFRA Category 7A	Rinse-off products applied to the hair with some hand contact
IFRA Category 7B	Leave-on products applied to the hair with some hand contact
IFRA Category 8	Products with significant anogenital exposure
IFRA Category 9	Products with body and hand exposure, primarily rinse off
IFRA Category 10A	Household care excluding aerosol products (excluding aerosol/spray products)
IFRA Category 10B	Household aerosol/spray products
IFRA Category 11A	Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate without UV exposure
IFRA Category 11B	Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate with potential UV exposure
IFRA Category 12	Products not intended for direct skin contact, minimal or insignificant transfer to skin
