## ANNEX 1

Below is an extract of information provided by IFRA in relation to types of application present in each IFRA Category. Additional information about IFRA Categories can be found in the Guidance to IFRA Standards, issued by IFRA.

IFRA Category 1	Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, etc.); Childrens toys
IFRA Category 2	Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deo-cologne, etc.); Body sprays (including body mist)
IFRA Category 3	Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care and moisturizer; Facial make up and foundation; Make-up remover for face and eyes; Nose pore strips; Wipes or refreshing tissues for face, neck, hands, body; Body and face paint (for children and adults); Facial masks for face and around the eyes
IFRA Category 4	Hydroalcoholic and nonhydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragancing cream, etc.), aftershaves of all types (except creams and balms ); Fragranced bracelets; Ingredients of perfume kits and fragrance mixtures for cosmetic kits; Scent pads, foil packs; Scent strips for hydroalcoholic products
IFRA Category 5A	Body creams, oils, lotions of all types; Foot care products (creams and powders); Insect repellent (intended to be applied to the skin); All powders and talc (excluding baby powders and talc)
IFRA Category 5B	Facial toner; Facial moisturizers and creams (including care products for beard and mustache)
IFRA Category 5C	Hand cream; Nail care products including cuticle creams, nail lacquer remover, etc.; Hand sanitizers
