Below is an extract of information provided by IFRA in relation to types of application present in each IFRA Category. Additional information about IFRA Categories can be found in the Guidance to IFRA Standards, issued by IFRA.

| IFRA Category 5A | Body creams, oils, lotions of all types; Foot care products (creams and powders); Insect repellent (intended to be applied to the skin); All powders and talc (excluding baby powders and talc) |
